- To take the Advanced (CGCA) test, dogs must have passed a Canine Good Citizen (CGC) test that is on record with the AKC.
- You will fill out the official CGC Test Form at the event. You may submit a Test Form with a passing score to the AKC for an Official CGC Certificate (not a title, \$20), OR for an Official AKC CGC Title (with certificate, \$30) that will be listed on dog's title record.
- The dog's name as you fill it out on the Test Form (registered or call) is what will be printed on your certificate.

TESTING INFORMATION

- There is no minimum age for dogs to participate in these tests.
- All tests will be performed with the dog on a 4- to 6-foot leash. Retractable leashes are not allowed.
- Dog must be wearing a well-fitting buckle or slip collar (including martingales) or non-restrictive body harness.
- For CGC Test entrants: Please bring your dog's brush or comb for Test Item #3.
- Email confirmation will be sent upon receipt of entry and approx. running order will be sent 6/27/25.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge or evaluator judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons.
